The current contract has expired, and it is imperative to get a new contract and contractor in place for routine maintenance. Mr. Leadbetter is seeking approval to solicit bids from contractors to perform the services. Commissioner Roberts moved to approve as presented, Commissioner Vickrey seconded; the vote was unanimous.

COMMISSIONERS COMMENTS

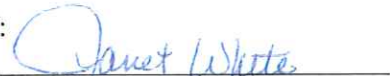
