EXECUTIVE SESSION

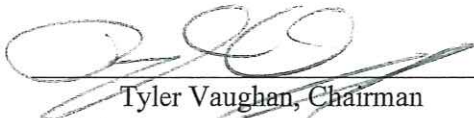

ADJOURNMENT

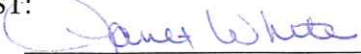
